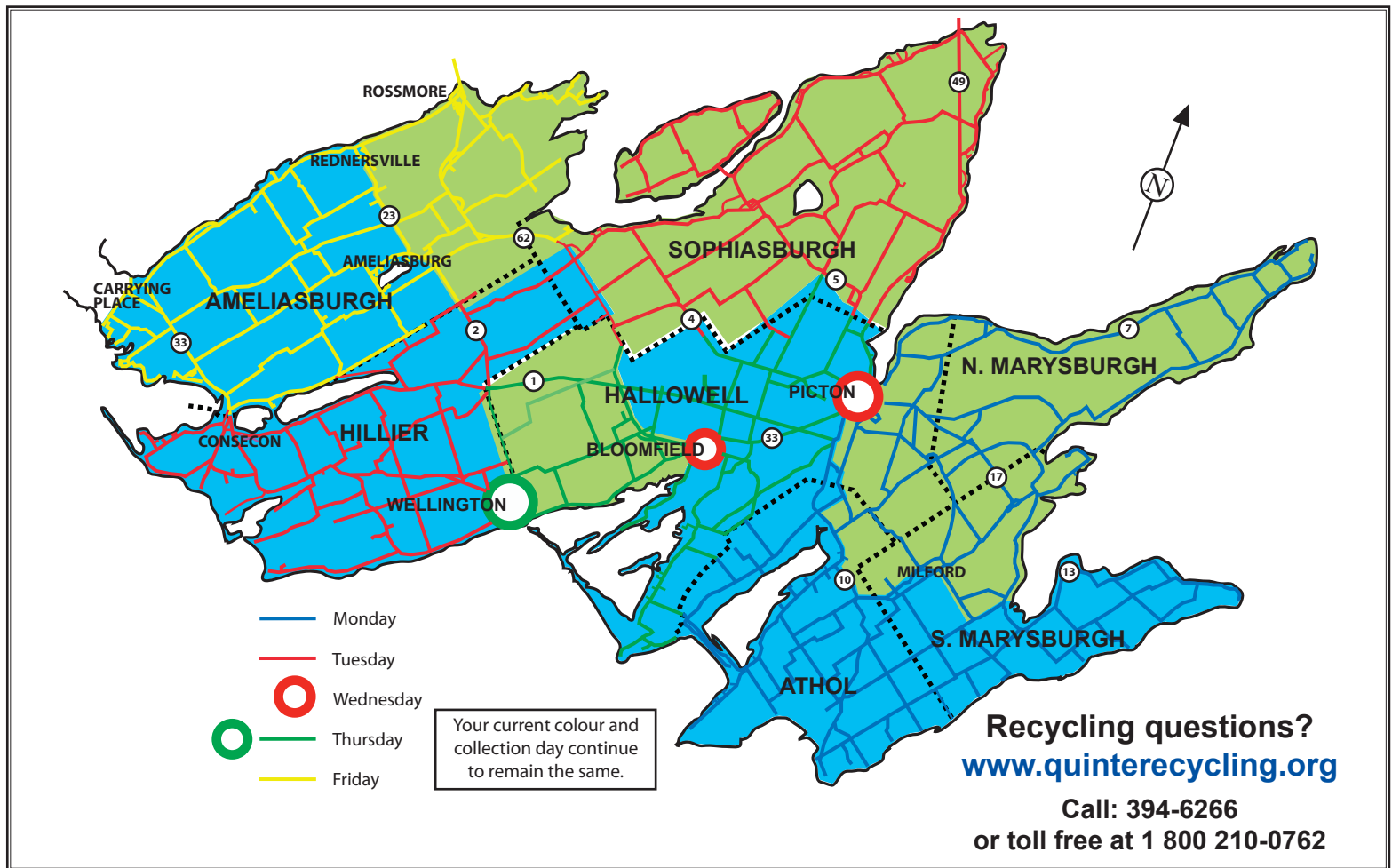

Corrugated cardboard (moving) boxes bundled 30" x 30" x 8"



Bag of plastic bags (grocery & rinsed milk bags etc...)

Cereal and tissue style boxes stuffed into one box
